### **SCHEDULE**

(A) It is hereby **RESOLVED** to amend the Rules of the Association as follows:

#### 1. **By adding new Rule 59A:**

"59A. Each full member of the ChBA who practises on his own account or is in a set of Chambers in which fewer than five persons are members of the ChBA shall set up a standing order for the payment of his annual subscription for membership and shall pay his annual subscription by standing order thereafter."

#### 2. By amending Rule 63 which currently provides:

"63. The annual subscription shall be paid by each member or each set of Chambers comprising full members (on behalf of the full members of the ChBA in those Chambers) on or before the 15th December prior to the calendar year to which the subscription relates."

#### So that it provides:

"63. The annual subscription shall be paid by each member or each set of Chambers comprising full members (on behalf of the full members of the ChBA in those Chambers) on or before the 31<sup>st</sup> January in the calendar year to which the subscription relates."

#### 3. By amending Rule 65 which currently provides:

"65. Any member of the ChBA whose subscription is in arrears shall cease to be a member of the ChBA, but may be re-admitted to membership by the Committee on payment of the arrears and of such subscription as he would have paid if his membership had not ceased."

#### So that it provides:

- "65. Any member of the ChBA whose subscription is one month in arrears shall cease to be a member of the ChBA, but may be re-admitted to membership by the Committee on payment of the arrears and of such subscription as he would have paid if his membership had not ceased."
- (B) It is hereby **RESOLVED** that £10,000 being the identified surplus of the Association's General Account be donated as to one half to the Bar Pro Bono Unit and as to the other half to the Barristers' Benevolent Association.
